He served at the White House, as Associate Counsel in the Office of the Vice President and as Special Counsel to the President's Crime Prevention Council. He was a member of the litigation team that defended the U.S. Food and Drug Administration's administrative rule aimed at protecting young people from tobacco.

Greg has extensive experience in trial work and dispute resolution, including fast-track injunction and TRO hearings, jury and bench trials, arbitration, mediation, and settlement negotiation. He is a forceful and effective advocate with judges, juries, and mediators, and is able to speak knowledgeably and effectively with government regulators.
